

School Board Member Candidate Survey: 2023

Question 1: The legislature is considering state funding for private school vouchers. As a school board member, would you agree or disagree with the idea of using public funds for private school vouchers?

Re: Question 1 - Private school vouchers treat the education of our children like a commodity rather than a long term investment in children and communities. Vouchers also strip money from schools and harm children with special academic needs.

Question 2: The PA Senate is now considering legislation (HB 1422 that has passed through the House) that would modernize Pennsylvania's charter school law to ensure transparency, accountability and fiscal responsibility. As a school board member, would you agree or disagree with this approach to regulating charter schools?

Re: Question 2 - Like private schools, charter schools strip money from public schools which exacerbates the primary issues that schools face. Cyber Charter Schools in particular consistently rank as the lowest performing schools in Pennsylvania and collect more funds from school districts than they pay out to educate a single student.

Question 3: Do you agree or disagree that working with teachers unions is necessary to address the teacher shortage crisis in our state?

Re: Question 3 - Teacher shortages are caused by low pay and low morale. Teachers are well educated and one of the most important careers in the country but are treated poorly by political groups with no experience or understanding of the education system. Like all workforces, all teachers deserve union representation so that the service and sacrifice they make for the good of their students and our children is not taken advantage of.
